**How Winners Are Selected:** Photo contest winners will be selected by a panel chosen by the Franklin County Visitors Bureau.

## CONTEST RULES

1. Anyone is eligible to enter; all photos must be taken at Fort Loudoun. It can include the weekend of Fort Loudoun's 250th Black Boys Rebellion event (September 25-27) and can include landscape, wildlife and scenery.
2. Photos must be the original work of the individual submitting the photo/image file.
3. Submit your photos to the Franklin County Visitors Bureau by email at [lcappuccio@explorefranklincountypa.com](mailto:lcappuccio@explorefranklincountypa.com) or in person at 37 South Main Street Suite 100, Chambersburg, PA. Each image submitted must have

a completed entry form and release form as appropriate to be eligible. Re-enactors will not need to sign a release form.

4. By entering the contest, you are agreeing to provide the Franklin County Visitors Bureau with indefinite and infinite use of the image/photo and the Fort Loudoun Historical Society use for promotion.

5. Entrants in the contest agree to the contest rules and accept the decision of the judges as final.

6. Photos must be received no later than Sept. 30, 2015 to be eligible for the contest.

7. Fort Loudoun Historical Society/Franklin County Visitors Bureau employees and members of their immediate families are not eligible to win prizes.

8. 1st place will receive \$100 and the two honorable mentions will receive a goody basket as compiled by the Franklin County Visitors Bureau.
